Minutes of Laurel Lodge #237 F&AM

November 3rd AD 2023 AL 6023

Lodge was opened in Due and Ancient Form by Worshipful Jerry R. Barnish WM at 8:04 PM followed by a brief talk from an FBI agent starting at 7:15 whom our WM invited to come in and discuss with the Brethren about being prepared in case of a gunmen or other emergency situation which could arise with the escalation of the increasing violence going on around us.

It is hoped that Special Agent Randolph will be coming out in the future when time permits. After the Opening Minutes of the last communication were read and approved. The Secretary was called upon to read the following Bills:

\$116.59 from the PM Night Dinner to WB Bob Taylor.

\$50.31 placed on the Lodge Debit card by WB Bob Taylor for PM Night Dinner.

\$23.98 to Jerry Barnish WM for refreshments after the meeting

\$123.26 Comcast Business

\$96.00 MacFerrans Printing

A motion was made by Bro Keith Verrico and seconded by WB Don Keppen Jr Jr Warden to pay the bills. There were no petitions or correspondence MW Joe Rival then made his report which was accepted and sent to the auditing committee. MW Brother Rival was then recognized and reported to the Lodge about his difficulties with TD bank stating that he had done what they asked of us as our purpose was to open an account so that the Brethren could pay their dues and for various other Lodge activities, he being the Treasurer of Laurel Lodge was empowered by the Lodge to do so in our interest but since there were various issues with TD Bank he suggested we find another bank. It was suggested that WB Bob Taylor our Senior Deacon along with MW Rival will act on behalf of the Lodge in seeking another institution to set up accounts and to be signatories for the Lodge.

A motion was made by WB Craig Woodruff to close the account and to open another account in a different institution, starting off with a \$250 dollar deposit or what would be suitable for the new institution to be able to open an account. This was seconded by Bro Keith Verrico and after being amended 3 times it was voted upon and passed that MW Bro Rival Treasurer and WB Bob Taylor Senior Deacon both be signatories on behalf of Laurel Lodge for this purpose.

The Worshipful Master then called upon RW Al Hann for a sick and Visiting report. He stated that he had made no phone calls or visits but did say it was great to see RW Frazier Alburger, Grand Tyler out and thanked him for doing an outstanding job for his term as Grand Tyler. It was reported that Brother Pavlovec's wife has breast cancer and that she needs our prayers. Get well and sympathy cards were left in the foyer for Brethren to sign. WB Bob Taylor thanked the Lodge for the sympathy card he received on behalf of his Father in Laws passing, who was also WB James Weisensee's Fathers.

As members of this Lodge, Brethren should be making reports or passing along information pertaining to each other so that we can be there to offer assistance and prayers for them.

The WM then apologized for not having the visit to the BBNJ due to family issues and is hopeful that it may take place next year. He talked about the prestigious museum and programs that are happening there.

A motion was made by MW Rival to have the Lodge pay for half of the planned PM Dinner to be held on Nov 14th at Philomenas in Blackwood this was seconded by WB Don Keppen Jr, motion passed. WB Joe Abiuso PM was recognized, he talked about the Feast of Saint John and asked if the Lodge could sponsor a Veteran to go, cost is \$45 following this he told the Lodge how he was walking past a high rise construction site and beheld a beautiful female construction worker and exclaimed what a riveting experience it was.

The WM asked if there were Brethren present celebrating Masonic Birthdays. MW Joe Rival PGM (52), DB Ray McManus (33), Bro Jim Greiner (14), WB Joe Abiuso (14) and RW Jim Miller (40) all presented themselves west of the alter and after announcing themselves and the Sr Deacon announcing 153 years of Freemasonry were escorted to the East to be greeted and presented with their Masonic B Day gifts. There was no correspondence to be read. The Secretary was recognized and read

A secret majority ballot was held for the reinstatement of WB Ray Kingett PM, which passed unanimously. He is now reinstated into this Lodge.

MW Bro Rival was called upon to make his treasurers report which was accepted and sent to the auditing committee. It was again brought up to the lodge by MW Bro Rival Treasurer of Laurels intentions to open a new account and he mentioned opening it with PNC bank since he and WB Bob Taylor are acting on behalf of the Lodge in this endeavor and that we will try to make a pay pal account in order that our members may be able to use it for things pertaining to the lodge as well as for online dues payments .

The WM thanked MW Bro Rival and requested that he leave. During his absence the WM addressed the Brethren stating that since MW Bro Rival is retiring this year that we should make him Treasurer Emeritus since he has always had the Laurels best interests in mind. A motion was then made by Bro Keith Verrico SW and seconded by RW Scott Vicari to make MW Rival Treasurer Emeritus after his term of office has expired which passed unanimously.




