Worshipful Masters Message

Brethren,

Bringing 5 candidates into the lodge last meeting, and speaking to them after the degree, reminded me of many discussions with education classes regarding what Masonry really is, the obligations, and more specifically, the penalties of the obligations. Essentially, Freemasonry is a fraternity which stresses self-development of the individual's intellectual and spiritual nature. It teaches self-control and the development of insight. It teaches primarily through the use of symbols and allegory and its rituals and ceremonies are designed for that quest. The obligations are the things we promise to do or not to do. The penalties are the consequences we offer to undergo if we break our obligations. The penalties are symbolic, not real, and coincide with each degree for specific reasons.

In the Entered Apprentice Degree, you promise little more than to keep confidential those things which should be kept confidential. In the Fellow Craft Degree, the promises are greater, and is appropriate for one who is now supposed to have his passions within due bounds and to be moving to a higher level of thinking, continuing on into the Master Mason Degree. The penalties seem, at first, to be unbelievably cruel and heartless. It comes as a shock to learn that these were all penalties actually used by the legal systems in Europe during the 1500's-1700's. In order to understand the symbolism, it is necessary to know what was "factual" at that time. In the days when the ritual of Masonry was developing, knowledge and understanding were thought to be in the heart, not the brain. We still speak of learning something "by heart", or "knowing something by heart". Intuition and emotional comprehension and sensitivity were thought to be in the intestines. Thus, you will find many references to the "bowels of mercy", or "feeling in the gut", or "gut instinct", when we mean something that we know is true without knowing how we know, known as "intuition". You will note that the penalty for each Obligation involves the destruction of the part of the body which was abused or misused in the breaking of the obligation, i.e. EA- silence, FC-knowledge, or MM insight/intuition. The Penalty for each Obligation corresponds to the position of the cable tow for that Degree.

Also, during ancient times, the world and universe were thought to be composed of 5 elements. The first 4 are physical being earth, air, fire, and water. The fifth element was the spiritual. From the first to third degree, these are represented in the penalties as (earth-water), (earth-air), and (fire-air). The more you learn, the more you realize there is to know, especially when it comes to Masonry.

With that, I am reminded of a saying I heard many years ago. “You graduate high school thinking you know all there is to know, and graduate college knowing how limited your scope of knowledge really is.”

Brethren, do you have a Friend that's expressed interest in joining Freemasonry?

In the U.S., generally, these are the requirements for becoming a Mason:

Be a man who comes of his own free will.

Believe in a Supreme Being (the form of which is left to open interpretation by the candidate).

Be at least the minimum age (from 18–25 years old depending on the jurisdiction. In some jurisdictions the son of a Mason, known as a “Lewis,” may join at an earlier age than others).

Be of good morals, and of good reputation.

Be of sound mind and body (lodges had in the past denied membership to a man because of a physical disability; however, now, if a potential candidate says a disability will not cause problems, it will not be held against him).

Be free-born (or “born free”, i.e., not born a slave or bondsman). As with the previous, this is entirely an historical holdover, and can be interpreted in the same manner as it is in the context of being entitled to write a will. Some jurisdictions have removed this requirement.

Be capable of furnishing character references, as well as one or two references from current Masons, depending on jurisdiction.

My Brothers,

When I was running to serve as your Junior Grand Warden in 2015, I promised you that if elected, I would strive to bring transparency to the brethren concerning the finances of our Grand Lodge. Almost two years ago, I proposed legislation that was adopted, mandating the publishing of the audited Grand Lodge finances. After numerous months, once all the paperwork was completed, the final report of the independent auditor has been received and the findings are startling. I held a meeting on Friday, March 8, 2019 with the independent auditor, the elected line, Grand Lodge office administrator, Acting Grand Secretary, President of the Grand Lodge Board of Trustees and the audit committee. The purpose was to review the independent auditors report.

It goes without question that for some time, there has been questions related to the finances of the Grand Lodge, to which before I even served as a member of the progressive elected Grand Line, I shared in your concerns. Now as your Grand Master, I believe it is my Masonic and fiduciary responsibility to report to you on our findings.

In reviewing the internal audit of our Grand Lodge records, there was a concern that money from the Grand Lodge was owed to the Masonic Charity Foundation of New Jersey ("MCF"); however, there was no clarity as to the extent of how much the Grand Lodge owes the Foundation until this past week when the final independent audit report was provided. Although the independent audit has confirmed that our past-due pass-throughs to The George Washington Masonic National Memorial, New Jersey DeMolay and New Jersey Rainbow for Girls were fully satisfied, it has been determined that the Grand Lodge has not been current on its pass throughs to the MCF. Specifically, as per the independent audit, as of April 30, 2018, the Grand Lodge owed the MCF the sum of \$393,728.00, which consists of unpaid home fees for initiates in the amount of \$117,505.00 and for home maintenance fees in the amount of \$276,223.00. The pass-throughs are the donations collected through your dues payments which are part of the Grand Lodge assessment. These donations are earmarked for the Masonic Charity Foundation,

Rainbow, DeMolay, HTMT and George Washington Memorial. You pay them through your dues which in turn, your lodge remits to the Grand Lodge yearly with its annual return. For several years, these donations were not fully passed through to Charities. The minutes of the Grand Lodge trustees reflect the elected line and I, when given reports of the deficiencies, demanded that they be fully paid. We can only demand the arrears to be paid which we were made aware of. The reports were conflicting. Originally, we were told we were up to date by the Grand Lodge office as the minutes of the Grand Lodge Trustees reflect. We were informed that Rainbow, DeMolay were paid their delinquent pass-throughs. On 6/27/17 the George Washington National Memorial was paid \$164,261.00 of delinquent pass-throughs. Just recently the HTMT was brought current. I questioned the monies due the Masonic Charity Foundation and was told by the Grand Lodge office they did not know why Grand Lodge IRS filing of the 990 in 2016 showed \$280,709 as owed to the Foundation. My Brothers, the audit by an independent professional auditor shows the Grand Lodge owes \$393,738.00 as of the date of this letter to you! This is from years of partial payments and, lately nonpayment, as of April 2018. The auditor used the actual amounts paid through your lodges' annual returns and compared these annual payments to the payments made/passed through to the Charities by the Grand Lodge office.

My brothers, this is unacceptable and the MCF must be made whole immediately. There is a potential issue with the IRS if we don't. Our 501c10 status is at risk.

The Grand Lodge simply does not have sufficient money in its general operating account available to pay the balance due the MCF. Indeed, nor does the Grand Lodge budget committee can anticipate a surplus anywhere close to that size next fiscal year to satisfy the balance due the MCF.

In light of the foregoing, I am calling a Town Hall Meeting for, April 5, 2019 at 7:00 P.M. at the Fellowship Center, located at Masonic Villages at Burlington, NJ. The purpose of this Town Hall is to present to you in greater details the results of the audit, and to discuss options to immediately address this deficit. In order for you to be properly informed as to the finances of the Grand Lodge in preparation for the annual communication on April 17-18 and the potential pieces of legislation that will have to be adopted at that session to address this significant deficit due MCF, it is necessary that the Town Hall occur prior to the annual communication.

Lastly, your progressive elected grand line and I are further considering other protective measures for compliance purposes to ensure that this never occurs again. Those will be discussed at great length soon. I encourage your active involvement in the discussion as we work together to resolve this
